The South Carolina Department of Natural Resource (the SCDNR) currently maintains a fleet of 3 mission-ready aircraft (two single-engine aircraft and one twin-engine aircraft). These aircraft are used for both law enforcement and biology missions. The law enforcement missions include search and rescue, night patrols for illegal deer hunting, migratory bait flights, and offshore patrols. The biology missions include eagle surveys, turtle flights, marine mammal flights, and migratory bird population surveys. These aircraft are also made available to other state agencies such as SLED and the Department of Public Safety when needed. The SCDNR currently employs two full-time pilots to fly its aircraft.

The newest aircraft in the SCDNR's fleet is a 2004 Vulcanair P68 Observer. This is a twinengine aircraft that is equipped with a Forward-Looking Infrared (FLIR) system for night-time operations. The P68 is in great shape and continues to meet the SCDNR's mission needs for a twin-engine aircraft. However, the SCDNR's two single-engine aircraft are both over 40 years old. The oldest is a 1984 Cessna Centurion and the other is a 1985 Cessna Stationair. In FY25, the SCDNR requested non-recurring funding to purchase one new single engine aircraft that meets its mission needs to replace the two Cessna aircraft in the fleet. In the FY2025-26 Annual Appropriations, the General Assembly budgeted \$2,000,000 in Part I B Budget Proviso 11 8.22(B)(44)(a) for the SCDNR to purchase a new aircraft. The SCDNR intends to use these funds to purchase a new Cessna 206 Stationair HD. The Cessna 206 Stationair HD is a modem single-engine version of the current Cessna 206 already used within the SCDNR's fleet. The SCDNR desires to purchase a single-engine Cessna because this is the aircraft that its pilots are trained on and are comfortable flying at lower altitudes and slower speeds. These low altitude missions can be dangerous, so it is imperative that the SCDNR keep its pilots in a plane that meets this specific mission need. The SCDNR's pilots are also familiar with the maintenance required on the Cessna 206, and purchasing a newer model of the same aircraft will make it easy to keep up with maintenance issues. The SCDNR has received a quote from Textron Aviation, Inc., the manufacturer, in the amount of \$1,142,940.

The SCDNR requests authorization per Section 1-11-405 to submit offers; make deposits; and proceed with a purchase of Cessna 206 Stationair HD; all in accordance with the plan as described herein. The request for this acquisition was reviewed favorably by JBRC at its October 7, 2025, meeting.

Exhibit A

SECTION 1-11-405. Aircraft purchase, lease, or lease-purchase by state agency.

No aircraft may be purchased, leased, or lease-purchased for more than a thirty-day period by any state agency without the prior authorization of the Department of Administration or the State Fiscal Accountability Authority, as appropriate, and the Joint Bond Review Committee.

HISTORY: 1995 Act No. 145, Part II, Section 44.

Code Commissioner's Note

At the direction of the Code Commissioner, references in this section to the offices of the former State Budget and Control Board, Office of the Governor, or other agencies, were changed to reflect the transfer of them to the Department of Administration or other entities, pursuant to the directive of the South Carolina Restructuring Act, 2014 Act No. 121, Section 5(D)(1), effective July 1, 2015.

SECTION 11-35-710. Exemptions.

- (A) The board, upon the recommendation of the chief procurement officer, may exempt governmental bodies from purchasing certain items through the respective chief procurement officer's area of responsibility. The board may exempt specific supplies, services, information technology, or construction from the purchasing procedures required in this chapter and for just cause by unanimous written decision limit or may withdraw exemptions provided for in this section. The following exemptions are granted from this chapter:
- (1) the construction, maintenance, and repair of bridges, highways, and roads; vehicle and road equipment maintenance and repair; and other emergency-type parts or equipment utilized by the Department of Transportation or the Department of Public Safety;
- (2) the purchase of raw materials by the South Carolina Department of Corrections, Division of Prison Industries;
 - (3) South Carolina State Ports Authority;
 - (4) Division of Public Railways of the Department of Commerce;
 - (5) South Carolina Public Service Authority;
- (6) expenditure of funds at state institutions of higher learning derived wholly from athletic or other student contests, from the activities of student organizations, and from the operation of canteens and bookstores, except as the funds are used for the procurement of construction, architect-engineer, construction-management, and land surveying services;
 - (7) livestock, feed, and veterinary supplies;
 - (8) articles for commercial sale by all governmental bodies;
 - (9) fresh fruits, vegetables, meats, fish, milk, and eggs;
- (10) South Carolina Arts Commission and South Carolina Museum Commission for the purchase of one-of-a-kind items such as paintings, antiques, sculpture, and similar objects. Before a governmental body procures the objects, the head of the purchasing agency shall prepare a written determination specifying the need for the objects and the benefits to the State. The South Carolina Arts Commission shall review the determination and forward a recommendation to the board for approval;
 - (11) published books, periodicals, and technical pamphlets;
 - (12) South Carolina Research Authority;
- (13) the purchase of supplies, services, or information technology by state offices, departments, institutions, agencies, boards, and commissions or the political subdivisions of this State from the South Carolina Department of Corrections, Division of Prison Industries;
- (14) Medical University Hospital Authority, if the Medical University Hospital Authority has promulgated a procurement process in accordance with its enabling provision;
- (15) if approved in writing by the State Engineer in advance, and if some aspect of the overall transaction is otherwise approved by the board in advance of the acquisition, an acquisition of construction from an eleemosynary corporation or foundation, or a wholly owned business thereof, established solely for the governmental body's benefit, but only if the eleemosynary corporation or foundation acquires the construction on behalf of or for the use of the governmental body and does so pursuant to this code, as required by Section 11-35-40(4).
- (B) The State Fiscal Accountability Authority shall maintain and post publicly a running list of all currently effective actions taken by the board pursuant to subsection (A).

SECTION 118 - X910 - STATEWIDE REVENUE

118.21. DELETED

- **118.22.** (SR: Nonrecurring Revenue) (A) The source of revenue appropriated in subsection (B) is nonrecurring revenue generated from the following sources:
 - (1) \$332,294,362 from Contingency Reserve Fund;
 - (2) \$1,226,554,400 from Fiscal Year 2024-25 Projected Surplus;
 - (3) \$34,054,856 from Litigation Recovery Account;
 - (4) \$1,643,873 from Fiscal Year 2024-25 Projected Debt Service Lapse;
- (5) \$109,752,745 from Fiscal Year 2025-26 Debt Service Appropriated Above Obligations;
 - (6) \$2,290,000 from Fiscal Year 2024-25 Governor Vetoes;
 - (7) \$6,254,723 from Excess Statewide Employee Benefits;
 - (8) \$4,000,000 from Workers' Compensation Commission Overage of IT Project;
 - (9) (5,079,000) for Fiscal Year 2024-25 Incremental Income Tax Reduction; and
 - (10) any residual certified unappropriated general fund dollars.

Any restrictions concerning specific utilization of these funds are lifted for the specified fiscal year. The above agency transfers shall occur no later than thirty days after the close of the books on Fiscal Year 2024-25 and shall be available for use in Fiscal Year 2025-26.

This revenue is deemed to have occurred and is available for use in Fiscal Year 2025-26 after September 1, 2025, following the Comptroller General's close of the state's books on Fiscal Year 2024-25.

(B) The appropriations in this provision are listed in priority order. Item (1) must be funded first and each remaining item must be fully funded before any funds are allocated to the next item. Provided, however, that any individual item may be partially funded in the order in which it appears to the extent that revenues are available.

The State Treasurer shall disburse the following appropriations on February 20, 2026, for the purposes stated, with the exception of items (1) and (68)(b) which shall be disbursed by September 30, 2025.

The overall cost for the new Cessna 206 with updated avionics and navigation is estimated at \$2,625,000.

Dear Mr. White:

The SC Department of Natural Resources (SCDNR) needs to purchase an additional fixed-wing aircraft for our fleet. The Agency would like to request an exemption from SC Consolidated Procurement Code to make this purchase. This letter will provide details on our current fleet as well as justification for the additional aircraft.

The SCDNR currently maintains a fleet of 3 mission-ready aircraft (two single-engine aircraft and one twin-engine aircraft). These aircraft are used for both law enforcement and biology missions. The law enforcement missions include search and rescue, night patrols for illegal deer hunting, migratory bait flights, and offshore patrols. The biology missions include eagle surveys, turtle flights, marine mammal flights, and migratory bird population surveys. These aircraft are also made available to other state agencies such as SLED and the Department of Public Safety when needed. The SCDNR currently employs two full-time pilots to fly our aircraft.

The newest aircraft in our fleet is a 2004 Vulcanair P68 Observer. This is a twin-engine aircraft that is equipped with a FLIR system for night-time operations. The P68 is in great shape and continues to meet our mission needs for a twin-engine aircraft. Our two single-engine aircraft are both over 40 years old. The oldest is a 1984 Cessna Centurion and the other is a 1985 Cessna Stationair. In FY25, the SCDNR requested non-recurring funding to purchase one new single-engine aircraft to replace the two Cessna aircraft in the fleet. The idea was to reduce our overall fleet and purchase a new aircraft that will meet our mission needs.

In the FY2025-26 Annual Appropriations, the General Assembly budgeted \$2,000,000 in Part 1B Budget Proviso 118.22(B)(44)a) for the SCDNR to purchase a new aircraft. The SCDNR would like to use these funds to purchase a new Cessna 206 Stationair HD. The Cessna 206 Stationair HD is a modern single-engine version of the current Cessna 206 already used within our fleet.

The SCDNR would like to purchase a single-engine Cessna because this is the aircraft that our pilots are trained on and are comfortable in flying at lower altitudes and at slower speeds. These low altitude missions can be dangerous, so it is imperative that we keep our pilots in a plane that

meets this specific mission need. Our pilots are also familiar with the maintenance required on the Cessna 206, and purchasing a newer model of the same aircraft will make it easy to keep up with maintenance issues. The SCDNR has reached out to Textron Aviation (maker of Cessna) about new aircraft availability. Textron is currently 6 months to 1 year out on production if you were to purchase an airplane today. If the SCDNR had to put an aircraft out for bid, it is likely that Textron will not even attempt to make a bid as their production schedule is already booked.

The SCDNR has received a quote from Textron Aviation in the amount of \$1,142,940. This quote is included with the email and this letter. Due to the high demand for these aircraft and the specific mission that the Cessna 206 provides for the Agency, the SCDNR would like to request an exemption to be able to purchase an aircraft directly from Textron.
