SUBJECT:SC Forestry Commission Acquisition of Conservation Easements over  $\pm 61,340$ acres of Forested Land

The SC Forestry Commission (Forestry) is requesting approval to acquire four (4) Conservation Easements over a combined total of  $\pm 61,340$  acres of land as part of the Pee Dee Basin RMS initiative (the "Project") in Marion, Georgetown and Williamsburg counties as follows:

- Evergreen Evergreen Timberco SC LLC will grant a Conservation Easement to Forestry consisting of ±8,666 acres of substantially natural and undeveloped forested land in Georgetown and Williamsburg counties for \$11,900,000, which is the appraised value of the easement.
- Oak Mountain Oak Mountain Timberco SC LLC will grant a Conservation Easement to Forestry consisting of ±14,124 acres of substantially natural and undeveloped forested land in Georgetown and Marion counties for \$14,500,000 which is the appraised value of the easement.
- Shades Mountain Timberco SC LLC will grant a Conservation Easement to Forestry consisting of ±2,751 acres of substantially natural and undeveloped forested land in Georgetown and Marion counties for \$3,400,000, which is the appraised value of the easement.
- Tamarack Tamarack Timberco SC LLC will grant a Conservation Easement to Forestry consisting of ±35,799 acres of substantially natural and undeveloped forested land in Georgetown County for \$39,100,000, which is the appraised value of the easement.

An additional  $\pm 880$  acres will be purchased in fee simple by Forestry, if approved, under a separate item included on this agenda, bringing the total Project area to  $\pm 62,220$  acres. Forestry has indicated that these conservation easements will conserve expansive working forests to benefit the timber economy while conserving habitat for at least 115 priority plant and animal species. The Project will also expand recreational opportunities for residents and visitors, with 7,567 acres open to the public for hunting, fishing and other recreational activities. Forestry will have the right to enter the properties for inspection and monitoring purposes and for enforcement of the terms of the Conservation Easements but will have no responsibility for operation or maintenance of the easement areas.

The Project is being funded as follows:

- For the purchase of the Conservation Easements: \$50,000,000 Forest Legacy Program Inflation Reduction Act Project Grant from the USDA Forest Service, \$17,300,000 contribution from the SC Office of Resilience, \$1,392,000 North American Wetlands Conservation Act grant, \$208,000 Acres Across America Grant.
- For the 880 acre fee simple acquisition (P12-9608): \$3,300,000 contribution from the SC Conservation Bank.

#### 3. Summary Background Information:

The SC Forestry Commission (Forestry) is requesting approval to acquire four (4) Conservation Easements over a combined total of  $\pm 61,340$  acres of land as part of the Pee Dee Basin RMS initiative (the "Project") in Marion, Georgetown and Williamsburg counties as follows:

- Evergreen Evergreen Timberco SC LLC will grant a Conservation Easement to Forestry consisting of ±8,666 acres of substantially natural and undeveloped forested land in Georgetown and Williamsburg counties for \$11,900,000, which is the appraised value of the easement.
- Oak Mountain Oak Mountain Timberco SC LLC will grant a Conservation Easement to Forestry consisting of ±14,124 acres of substantially natural and undeveloped forested land in Georgetown and Marion counties for \$14,500,000 which is the appraised value of the easement.
- Shades Mountain Timberco SC LLC will grant a Conservation Easement to Forestry consisting of ±2,751 acres of substantially natural and undeveloped forested land in Georgetown and Marion counties for \$3,400,000, which is the appraised value of the easement.
- Tamarack Tamarack Timberco SC LLC will grant a Conservation Easement to Forestry consisting of ±35,799 acres of substantially natural and undeveloped forested land in Georgetown County for \$39,100,000, which is the appraised value of the easement.

An additional  $\pm 880$  acres will be purchased in fee simple by Forestry, if approved, under a separate item included on this agenda, bringing the total Project area to  $\pm 62,220$  acres. The South Carolina Forestry Commission (SCFC) respectfully requests that this body approve the acquisition of conservation easements over 61,340 acres of forested land as the primary component of a conservation project known as the Pee Dee Basin RMS Initiative. The second component of this project, an 880-acre fee acquisition, also will be submitted to this body upon approval by JBRC. This request includes a description of the broader project for the purpose of transparency and to provide context for the proposed conservation easement acquisition.

The Pee Dee Basin RMS Initiative, located in the Northern Coastal Forest Legacy Program Focus Area, consists of approximately 62,220 ac. across three counties (Marion, Georgetown, and Williamsburg) and would be the largest, single conservation land protection project ever undertaken by a South Carolina State agency. Conservation easements totaling 61,340-ac. will be purchased by (SCFC) and held in perpetuity in an area threatened by development in the third-fastest growing state in the country. An additional 880 ac. will be purchased FEE SIMPLE by the SCFC and incorporated into Wee Tee State Forest, upon approval by the JBRC and SFAA. Of the total project acreage, 7,567 ac. will be opened to the public for hunting, fishing and other recreational uses.

Southern forests are the "wood basket" of the nation, and this project will conserve expansive working forests to benefit the timber economy while conserving habitat for at least 115 priority plant and animal species. The blocks making up this project vastly expand a corridor of protected lands including state parks, a state forest, wildlife management areas, and private lands to protect water resources and increase resiliency of South Carolina's landscape.

This project would not be possible without substantial financial commitments from several public and private partners. The larger project is primarily funded through a \$50 million Forest Legacy Program Inflation Reduction Act Project Grant from the USDA Forest Service, which requires 25% of non-federal matching funds. The majority of the match will be provided by a \$17.5 million contribution from the South Carolina Office of Resilience, in addition to an Acres Across America Grant and Lowcountry Landscape Grant, and others. The South Carolina Conservation Bank has agreed to fund the \$3.3 million purchase of the 880 ac. fee portion of this project. With over 70% of the funding coming from other sources, this project demonstrates significant financial leverage through substantial federal and private support.
