## State Fiscal Accountability Authority: Appointment of an Interim State Auditor (Regular Session Item #1)

By letter to Governor Henry McMaster on January 23, 2025, former State Auditor George Kennedy resigned as State Auditor effective that same day. Governor McMaster received and accepted Mr. Kennedy's resignation effective that same day.

Pursuant to SC Code of Laws Section 11-7-10, the Authority appointed an interim State Auditor who will be authorized to perform the duties of the State Auditor until such time as a permanent State Auditor is selected.

Upon a motion by Representative Bannister, seconded by Senator Peeler, the Authority

agreed to appoint Ms. Sue Moss as interim State Auditor. Ms. Moss is authorized to perform the duties of the State Auditor until such time as a permanent State Auditor is selected. Governor McMaster, Mr. Loftis, Senator Peeler, and Representative Bannister voted for the motion. Mr. Gaines abstained from voting on the motion.
